# 2019 Hangtown Days Foot Parade Entrant Waiver

As a parade entrant, I agree to cover any injury or damage caused by negligence or an animal in my charge to people or property.

As a parade entrant, I and on behalf of my entry hereby waive and release, and agree to defend (with counsel acceptable to City of Placerville), indemnify and hold City of Placerville, its officials, officers, employees, volunteers, agents (City Indemnitees); and parade sponsor Placerville Downtown Association free and harmless from and against any and all claims, demands, causes of action, costs, expenses, liability, loss, damage or injury, in law or equity, to property or persons, including wrongful death, in any manner which actually or allegedly arise out of or in connection with my entry in the parade, including but not limited to any alleged acts, omissions, negligence of the City of Placerville, its officials, officers, employees, agents, subcontractors and parade sponsor Placerville Downtown Association arising out of or in connection with the parade and including any alleged acts, omissions, negligence, active negligence or sole negligence of the City Indemnitees, and parade sponsor Placerville Downtown Association excepting only fraud, willful misconduct or violation of law by the City Indemnitees and parade sponsor Placerville Downtown Association. This shall include any and all such aforesaid suits, actions or other legal proceedings of every kind that may be brought or instituted against any of the City Indemnitees and parade sponsor Placerville Downtown Association.
